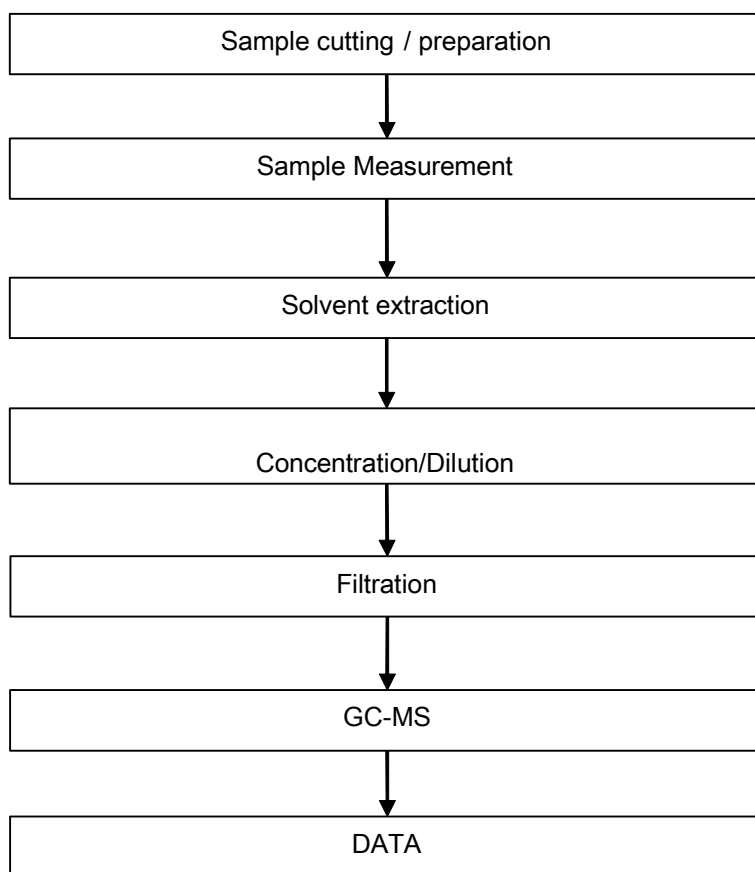

Phthalates Testing Flow Chart



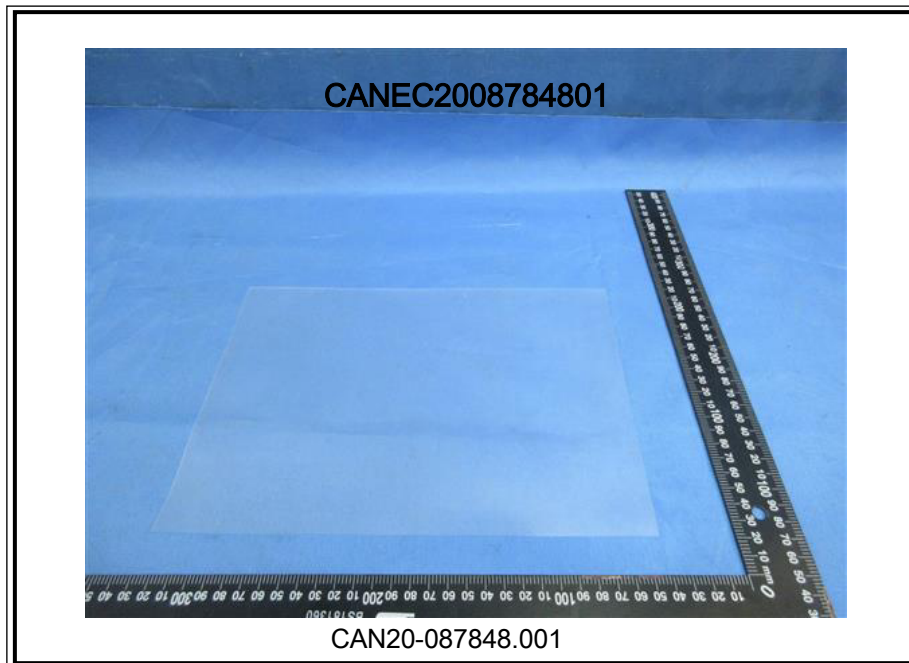
